Sir,

- i. I/We, the undersigned, certify that I/We have gone through the terms and conditions mentioned the tender document and undertake to comply with them.
- ii. I/We, the undersigned hereby bind myself/ourselves to the Lt. Governor of Delhi to supply the various items for C.N.B.C. Hospital, Delhi, during the period under Contract at the rates quoted by me/us.
- iii. The articles shall be of the best quality and kind as per requirement of the institution. The decision of the Medical Superintendent, C.N.B.C Hospital, Delhi (here in Affidavit called the said office) as regard to the quality and kind of articles shall be final and binding on me/us.
- iv. Earnest money of Rs. 25000/ (twenty five thousand only) in the form of FDR in favor of Dean, Maulana Azad Medical College, New Delhi is attached herewith and shall remain in custody of the Medical Superintendent till acceptance of the tender is made known.
- v. Should my / our tender be accepted this Earnest money of Rs.25,000/ May be treated security money for the said group.
- vi. I/We shall forfeit to Lt. Governor of Delhi the Earnest Money /Security Money deposited by me/us, if any delay occurs on my/ our part or fail to supply the articles the appointed place and time. The said officers may purchase those articles from any other source and deduct the extra amount, if any in connection therewith from the bills submitted I me/us or out of the Earnest Money/Security Money deposited by me /us.
- vii. I/We have prepared the Pre Qualification bid and Price -bid separately and is attached.
- viii. Should the said officer deem it necessary to change any article on its being found of inferior quality or not according to specification/samples, it shall be replaced by me/us in time to prevent inconvenience if any and to the full satisfactory of the Hospital. Decision of the Hospital in this regard shall be final and binding up on me/us.
- ix. I/We hereby undertake to supply the items during validity of tender as direction given in supply order within the stipulated period positively.
- x. I/We shall execute an agreement on stamped paper of Rs.50/- in case my/our tender is accepted and if I/We are asked to do so. The agreement will be executed by me/us within 7 days of the information of acceptance of rates/tender.

- xi. The conditions here in contained shall form part of and shall be taken as if they are included in the agreement to be entered into or treated as agreement itself at the discretion of Medical Superintendent, C.N.B.C. Hospital, Delhi.
- xii. I/We hereby undertake that the rates do not exceed the MRP mentioned in the item and at par as quoted to other Govt. Hospitals particularly hospitals falling under the jurisdiction of Govt. of Delhi.
