1. The firm has upload valid documents in support of EPFO registration, ESIC registration, Labour deptt. registration in the bid, otherwise bid will be summarily rejected.
2. Vendor has to provide 62 nos. of sanitary attendant and 03 nos. sanitary supervisor/inspector as per GeM bid. Further, deployment will be made in consultation with the hospital authority after giving weekly off and 03 national holidays to each sanitary attendant/supervisor. No relieving charges will be paid as manpower deployment will be within the mentioned numbers after giving weekly off.
3. Firm has to submit separate GST challan receipt tallied with the amount collected from deptt. and separate proof of salary disbursement through ECS by way of presenting bank statement for the workers deployed at CNBC, for that purpose contractor will not mix/merge the payment of other department with CNBC site. For non-compliance of this condition, a penalty of Rs. 10,000/- will be imposed on each occasion.
4. Contractor will pay bonus to the eligible employees as applicable on annual basis and accordingly firm will claim for reimbursement from the department after submission of proof of disbursement of Bonus through ECS.

5. No substitution/transfer of outsourced contractual personnel/staff shall normally be permissible, except under compelling circumstances and the same will be as per clause no. 3.10 of the OM no. 20/49/2016-AC/555-594 dated 04.08.2016 issued by finance department, GNCTD.
6. Firm has to comply all the applicable Acts, Minimum Wages, Rules and guidelines issued time to time by the Govt./ Regulatory bodies. Firm will disburse the wages as per applicable wages time to time and accordingly raise the bill along with proof of wages disbursement through ECS and proof of deposition of EPF, ESI & GST.
7. In case, if there is any finding against the contractor regarding exploitation of outsourced worker or in case of non-compliance of statutory provision by the contractor, then strict action will be taken against the contractor as per provisions of contract agreement, Labour Laws and other statutory provisions including forfeiture of performance security and black listing of the contractor/vendor.
8. Hospital authority reserves the right to terminate the Contract during its validity period without assigning any reason subject to serving a prior notice of three months. Further, contractor has also same right to terminate the contract by giving 03 months prior notice to the hospital authority.
9. Relieving charges & bonus factor not included in the calculation minimum wages per month as weekly off to be given to each worker from the total manpower defined, so relieving charges not required and bonus to be reimbursed per annum on actual as applicable in addition to wages calculation.

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.
