Terms & conditions

The cutoff date of age, qualification shall be the date of interview.

- 1. The candidates shall bring the complete prescribed application form along with bank draft (in original), original and one set of photocopy of self attested of educational/technical qualification certificates, experience certificates, caste certificates, DIVYANG (Physically Handicapped) certificates etc. at the time of interview.
- 2. The candidate shall report one hour before the interview.
- 3. The prescribed fees is Rs. 500/- for General & OBC candidates and Rs. 250/- for SC/ST Candidates in the form of Demand Draft in favour of Director, CNBC payable at Delhi/New Delhi. The fee is non refundable and no fee is payable by DIVYANG (Physically Handicapped) candidates.
- 4. The appointment is purely on contract basis for a period of 5 months (Against Maternity Leave) or till the regular incumbents which is on maternity leave joins, whichever is earlier,. This will not vest any right to claim for regular appointment in the hospital or for continued contractual appointment. The selected candidates should not approach higher Authority or initiate any legal course of action for extension of their contractual appointment or claim for permanent appointment.
- 5. A remuneration as mentioned above in accordance with the H&FW letter dated 19.11.2012 will be paid for each completed calendar month. For a period of less than one month, the payment will be made on pro-rata basis, as applicable on the date of commencement of the contract. No other service benefits or allowances are admissible

- 6. The word "recognized" means the course is run by the Hospitals of Delhi Govt/ Central Govt/State Govt. /Indian Medical Association and the course is approved by All India Council of Technical Education and State Boards of Technical Education and the course conducted by the Universities approved by UGC.
- 7. In case of receipt of a large number of applications for any post, a written screening test may be conducted and/or interviews can be held on two consecutive working days.
- 8. The upper age limit is 27 years as on the date of interview. The relaxation of age for OBC, SC, ST & DIVYANG (PH) candidates is as per Govt. rule.
- 9. The prescribed qualification is minimum and possessing of same does not entitle any candidate for selection.
- 10. The contractual engagement is purely on temporary basis and it can be terminated by the Employer during the period of the contract without assigning any reason or giving any notice.
- 11. Leave entitlement will be (2 ½) two and half days accrued Earned Leave for each completed calendar month. No other leave will be admissible. No encashment of leave is admissible.
- 12. The employee shall have to give one month notice or deposit an amount equal to one month remuneration if he/she wishes to terminate the contract immediately or without completion of the tenure.
- 13. Reservation for DIVYANG (Physically Handicapped) candidates will be given as per Govt. rules.
- 14. No TA/DA will be paid for appearing in the interview
- 15. In case the candidate is already employed, he/she should submit the NOC from his/her present employer.
- The candidates should not have been convicted by any court of law.
- 17. Canvassing in any form will render the candidate disqualified for the post.
- 18. If any declaration/ information furnished is found false or any material/fact suppressed willfully the contractual appointment will be terminated forth with.
- 19. The decision of the selection board regarding selection of the candidate will be final and no representation will be entertained in this regard.
- 20. In case of any dispute the legal jurisdiction will be Delhi only.
- 21. The candidates while appearing for interview will produce all original documents including mark sheets along with one number of attested photocopies of all testimonial/certificates and one passport size photograph.
- 22. The Competent Authority reserves the right to change the number of vacancies, withdraw the process, in full or in part without assigning any reasons or giving notice etc.
- 23. The selected candidate will have to accept the prescribed terms & conditions of appointment and to follow hospital wide policies.
- 24. The selected candidate will have to undergo mandatory induction training before joining the hospital.
