This hospital intends to out-source the MRI services for the patients of Chacha Nehru Bal Chikitsalaya, Geeta Colony, Delhi-110031.In this regards, you are requested to submit your quotation along with supportive documents as per eligibility criteria within 10 days from the issue of this letter, if willing to provide MRI services on outsource basis for CNBC patients. You are requested to submit quotation in two separate Envelopes:-

Part I- Envelope A having supportive documents as per eligibility criteria

Part II- Envelope B Financial quotation (Rate for Non contrast and Contrast MRI Scan for different body parts along with specialized MRI scan e.g. MRI spectro, MRCP, MRI Angio etc.)

Envelope A & B separately sealed and duly Super scribed as envelope" A" & "B "and both these envelope are to be put in a bigger cover which should also be sealed and duly Super scribed as "Quotation for outsourcing of MRI services in CNBC".

Eligibility Criteria for Service Providers:-

- 1) The Imaging centre should be NABH Accredited and should have **3 Tesla Machine**.
- 2) Centre should be located within a distance of 20km from this hospital.
- 3) Acceptance of term and conditions.

Scope of Services and Term & Conditions:-

- 1) Approximate monthly no. of 70-80 patients are prescribed MRI scan including both indoor & outdoor.
- 2) The Centre should allow one of the CNBC radiologists to be present when scan is in progress for judging requirement of any extra section / scan to be taken.
- 3) The waiting time for CNBC patients should be minimum (not more than 30 minutes).
- 4) Free of cost transport to be provided by the imaging centre for indoor patients (both to & fro).
- 5) The imaging centre will provide the services at the best possible rates but not exceeding DGEHS rates for MRI scans.
- 6) No extra charge will be levied by the centre for sedating/ anaesthesia imaging of the patient.

- 7) Beside the routine MRI scan, services for specialized MRI scan eg. MRI spectro, MRCP, MRI Angio etc. May be prescribed as per necessity.
- 8) A DVD of the MRI scan should be provided by the imaging centre, if any special software required for retrieving the data from DVD, the software should be shared with the hospital.
- 9) The timing for sending the patient for MRI scan will be 12:00 noon to 02:00 PM.
- 10) Days for MRI will be alternate days (3days a week).
- 11) The reporting of MRI and delivery of reports & films to the CNBC hospital should be with in 24 hours (next working day).
- 12) The services for MRI scan should have a 99% uptime.
- 13) Payment may be made directly by the patients to the centre on each scan as per rate quoted for this hospital.
