Terms & Conditions of Recruitment for SR & JR:-

- 1. The tenure of Sr. Residency is for a period of 3 years including any service rendered as Sr. Resident earlier on ad-hoc/ regular basis in any Govt. institution. The appointment will be initially for a period of one year, which could be extendable for a period of 3 years on an annual basis, subject to satisfactory work and conduct report from Head of Drpartment.
- 2. The tenure of Jr. Residency is for One year and the appointment will be initially for a period of six months which could be extended for further six months subject to satisfactory work and conduct report from Head of Department.
- 3. The Appointee shall have to give one month notice or deposit an amount equal to one month remuneration if he/she wishes to resign from the post before completion of tenure.
- 4. Inter-hospital, Inter -Institutional transfer shall not be permitted.
- 5. The service will be governed by Residency Scheme circular no F. No. 121/26/2010/H&FW/1996-2045 dated 10.06.11 issued by H&FW Department, Govt of N.C.T of Delhi.
- 6. The candidates who are already in Govt. service shall apply through proper channel.
- 7. If no suitable candidate with PG Qualification is available then candidates with three years experience in the specialty will also be considered for appointment on ad-hoc basis.
- 8. Registration from any Govt. State Medical Council is Compulsory and if selected DMC registration within one month is compulsory for all advertised Posts.
- 9. The candidates while appearing for interview will produce all relevant original documents along with one number of attested photocopies of all testimonial / certificates and one passport size photograph.
- 10. The candidate should report one hour before the time of interview.
- 11. No TA/DA shall be paid for attending the interview/written screening test.
- 12. The selected candidates will have to follow hospital wide policies.

- 13. Age relaxation for SC/ST/OBC/Ex-Serviceman/PH Candidates will be as per rules.
- 14. Candidates seeking benefits of reservation under SC/ST/OBC categories should produce the relevant certificates (issued before the date of submission of application) issued by competent Authority. In case of OBCs, the OBC certificate should be issued by Competent Authority of GNCT of Delhi.
- 15. If the candidate is not available from the reserve category, the posts will be filled from the un-reserved category on ad-hoc basis.
- 16. The application form in the prescribed performa can be typed/hand written and submitted in the Administration Branch at above mentioned address on or before the closing date in person or by post only along with the prescribed fee of **Rs 500/-** for UR & OBC candidates and **Rs. 250/-** for SC/ST candidates in the form of Demand Draft in favour of **Director CNBC payable at Delhi/New Delhi.** The fee is non refundable and no fee is to be payable by Physical Handicapped candidates.
- 17. The application received after due date will not be entertained. Hospital has no responsibility in postal delay.
- 18. The candidates should not have been convicted by any court of law.
- 19. Canvassing in any form will render the candidate disqualified for the post.
- 20. If any declaration/information furnished is found false or any material/fact suppressed willfully the appointment will be terminated forth with.
